Old Business

- 5. **Algoma Fire/Rescue Fundraiser** Groessl reported that they need between \$11,000.00 \$12,000.00 to purchase air bags(set of 6) and six infrared cameras. They have raised about half thus far. Ann made a motion to donate \$1000.00 to the Fire Department. Second by Peterman; motion carried.
- Farmers Market At our last meeting we pledged \$200.00 for the 2-day Kewaunee County workshop regarding Pop-Up Shops. Colburn will send a check for the same covering our pledge. This workshop is scheduled for October 24 in Casco.

Side note: Glime commented that he felt the posters were not done very professionally for this event. The logo is not clean on the posters or the website. He felt that the logo is a representation of the non-profit organization and should be clean and readable.

7. Murals: Dave Petry and Channel 26 were in Algoma today. The interviews will be broadcast on Tuesday, October 17 at 10:00 a.m. The mural between the two hardware stores is in bad need of repair. The suggestion was to tear down the fence first and then rebuild it. Also, the Sportsman mural needs cleaning before it is repainted. Jim commented that it is possible the mural on the old drug store may be painted over by the owner.
