After much discussion regarding annual Car Show and Wine Fest events, it was agreed that \$30,000.00 was needed to cover expenses. Weather was the number one factor ... never know what to expect. Peterman approved a 'nest egg' of \$30.000.00 to cover **annual** expenses; Kuhn second; motion carried.
